- Annual Payment Plan** Three payments of \$4333.33 due September 1, December 1, and April 1 \*
- Monthly Payment** Twelve payments of \$1083.33 are each due on August 15 and then on the first day of each month from September to July.
- Boarding Payment** Ten payments of \$600 each are due before the first day of each month from Sept. to June \*

\* All payments must be made by means of an approved payment plan (credit card, automatic bank draft, pre-dated checks, etc.) which I will be responsible to set up prior to August 15, 2022.



**I understand that in signing this Enrollment Contract for the coming academic year, I am agreeing to accept the rules and regulations of the school as stated in the current Student Handbook, and all of its future modifications. The undersigned agrees to release and hold harmless, the school, its agents and employees from all claims, damages or other liabilities for injuries to my child which are not the result of gross negligence by this school, its agents or employees. The undersigned also agrees to indemnify the school for damages by my child(ren). I hereby give permission for my child(ren) to attend all school-sponsored trips and activities. Furthermore, I agree to the policy of the school that student grades and transcripts will not be released unless an account has been paid in full. I understand that the school shall have the right to pursue legal action for collection of school tuition and fees and that parents will be responsible for all costs of collection, including court expenses and reasonable attorney's fees.**

Enrollment, as specified within this Enrollment Contract, may be canceled without penalty (except forfeit of the Registration Deposit) upon written notice received before August 15, 2022. If enrollment is canceled after August 15, 2022, parents or guardians financially responsible for the student(s) are obligated to pay the full annual charges.
